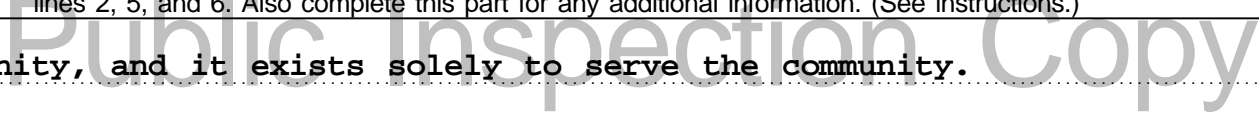

The Foundation's board of directors represents a cross-section of our community. The board brings together individuals with different socioeconomic profiles, interests, professional/career affiliations, and viewpoints. None of the board members is related to the staff or to any other member of the board. Term limits are imposed to ensure that no member becomes a fixture at the Foundation. To further expand the Foundation's outreach, non-board volunteers from the community are invited to participate on the Foundation's committees.

In conclusion, the spirit of the Foundation is wholly public - in the solicitation of funds, the election of board representation, and in the programming which the Foundation carries out within the community. The Foundation not only hears the voices of the community and acts upon the community's needs accordingly but it has been pro-active by convening groups that have grown into valuable assets to the community. The Foundation is in no way inaccessible, exclusive, or controlled by a small faction of its constituency. The Foundation has been built by the
